Minutes of the 18th University IQAC meeting held on 29 April & 05 May 2022 (2 days) under the Chairpersonship of Prof (Dr) Balvinder Shukla, Chairperson University IQAC and Hon'ble Vice Chancellor, AUUP.

- 1. After ascertaining the quorum for the meeting, Dr R S Rai, Director IQAC with the permission of Chair welcomed all the members of the University IQAC.
- 2. Opening Address by the Chairperson University IQAC At the outset the Chairperson University IQAC & Vice Chancellor, AUUP welcomed University IQAC members, external members, alumni members and all those present in the meeting.
- 2.1 The Chairperson briefed the house regarding the visit to US for WSCUC conference and said that in order to compete with international standards, we must benchmark our each and every activity. For example, California University for utilizing the data of learning outcome, progression of students etc, in making their strategic plans, etc.
- 2.2 She further apprised the forum about the achievements of AUUP for the quarter. The main highlights were:

 - Dr Shivani Verma of Amity Institute of Space Science Technology got a sanction letter of Technology Development Fund (TDF), DRDO under Atmanirbhar Bharat Scheme.
 - ▶ Dr (Mrs) Nutan Kaushik, Director General Amity Food & Agriculture Foundation has received recognition for "Exemplary Contribution to the growth and development of Bio-Agriculture in the continent in Bio-Ag Asia Awards 2022, by Agriculture Today Group and received the BioAgAsia22 award for "Special Achievement in developing promising biopesticide technologies and IPM Packages and thereby supporting organic agriculture of the country".
